**Re: Proposed Countryside Estates Street Reconstruction**

City Improvement Project #26-04 proposes to reconstruct the streets within the Countryside Estates and Wildwood Acres subdivisions, generally located east of Armstrong Boulevard (CSAH 83) and north of 173<sup>rd</sup> Avenue. A figure showing the scope of this project is attached. This project is included in the 2026 – 2035 Capital Improvement Program (CIP) for reconstruction in the summer of 2026.

On January 13, 2026 the Ramsey City Council approved final plans and specifications and authorized city staff to advertise for bids.

Preliminary Project Schedule:

- February 11, 2026 Bids are received and publicly opened.
- February 24, 2026 City Council awards a construction contract to the lowest responsible bidder.
- Spring 2026 Anticipated start of construction; this will be impacted by the Contractor's proposed schedule. Construction may not start until the summer months.
- Summer 2026 Project construction; the Contractor will be contractually obligated to substantially complete construction by August 28, 2026. Substantial completion includes the new bituminous pavement being in-place. Final completion, including final restoration of impacted boulevard areas being in-place, must be done by October 2, 2026.

A more detailed schedule will be provided after a contract is awarded and a pre-construction meeting is held with the contractor.

Proposed Improvements:

The reconstruction of the streets within Countryside Estates are proposed to be a Full-Depth Reclamation (FDR). FDR projects include: grinding up the existing pavement and aggregate base, hauling off excess material, exposing the underlying sand base to haul off additional material (the overall pavement section will be increased), placing aggregate base (made up of recycled reclaim material), shaping and compacting the aggregate base, and placing 2 lifts of new bituminous pavement on top. The streets will be put back to approximately the same location and elevation. Typical impacts of FDR projects include matching into the existing driveways and boulevards approximately 6 to 8 feet from the edge of pavement.

The reconstruction of the streets within Wildwood Acres are proposed to be a Reclamation. Reclamation projects include: grinding up the existing pavement and aggregate base, hauling off excess reclaim material, shaping and compacting the remaining in-place material, and placing a new lift of bituminous

pavement on top. The streets will be put back to approximately the same location and elevation. Typical impacts of reclamation projects include 1 to 2 feet of the boulevard adjacent to the pavement, as required to keep any vegetation and/or topsoil out of the reclamation. Driveway impacts are not anticipated.

Restoration of the impacted boulevards will include a minimum of 4-inches topsoil and hydroseed with a residential turf seed mix.

Property Impacts:

Access to abutting properties will be maintained throughout construction as best as practical. City staff will work with all property owners during construction to ensure they are informed in advance of any work that will affect and/or interrupt access to their property for any significant length of time, particularly due to reconstructing driveway aprons. Access for emergency services will be maintained throughout construction.

Project Funding:

The estimated project costs for the proposed improvements are \$2,561,355. Estimated costs include 23-percent indirect costs for administrative, engineering, finance, and legal costs. The improvements are proposed to be funded using a combination of Pavement Management Funds and Storm Water Funds. Property Owners will not be assessed for these improvements. This is an estimate based off of the final plans and anticipated 2026 construction costs. Final project costs may change depending upon bid prices and actual construction quantities.

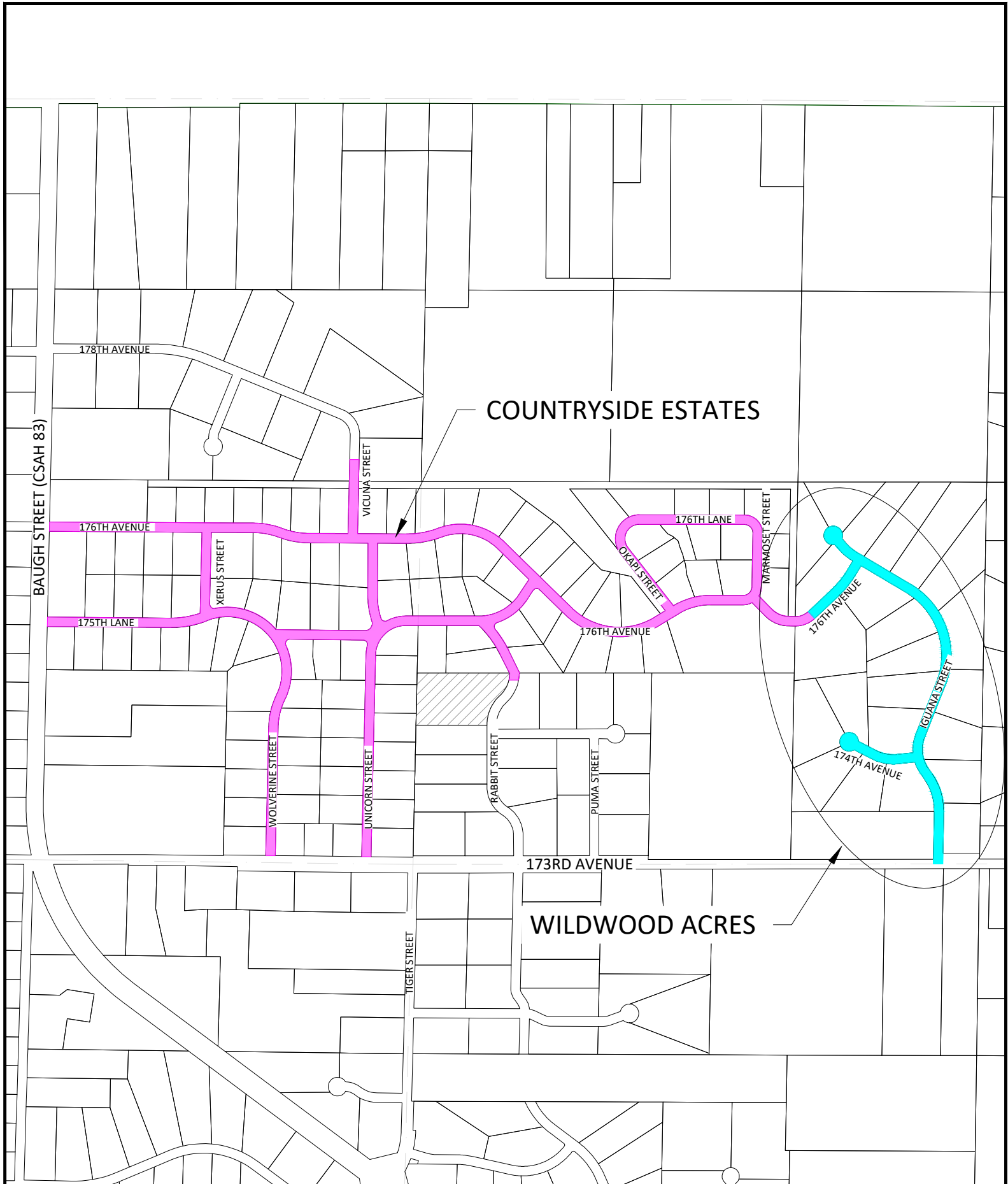
