AN ORDINANCE OF CITY OF FRUITLAND PARK, FLORIDA, RELATING TO THE STATE REVOLVING FUND LOAN PROGRAM; MAKING FINDINGS; APPROVING THE DRINKING WATER STATE REVOLVING FUND PLANNING, DESIGN AND CONSTRUCTION LOAN AGREEMENT FOR PROJECT DW350830 IN THE FUNDING AMOUNT OF \$347,004 WITH ESTIMATED PRINCIPAL FORGIVENESS OF \$173,502, ZERO PERCENT PER ANNUM INTEREST RATE ON THE UNPAID PRINCIPAL LOAN FOR A TERM OF 20 YEARS; ESTABLISHING PLEDGED REVENUES; DESIGNATING AUTHORIZED REPRESENTATIVES; PROVIDING ASSURANCES; PROVIDING FOR CONFLICTS, SEVERABILITY, AND EFFECTIVE DATE.

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare): The ordinance approves the Drinking Water State Revolving Fund Planning, Design and Construction Loan Agreement DW350830 and authorizes the mayor to execute the loan agreement with FDEP for funding through the State Revolving Fund Loan Program. The ordinance and the loan agreement adopted by the ordinance serves the public health, safety, morals and welfare of the City.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City, if any: No economic impact.
