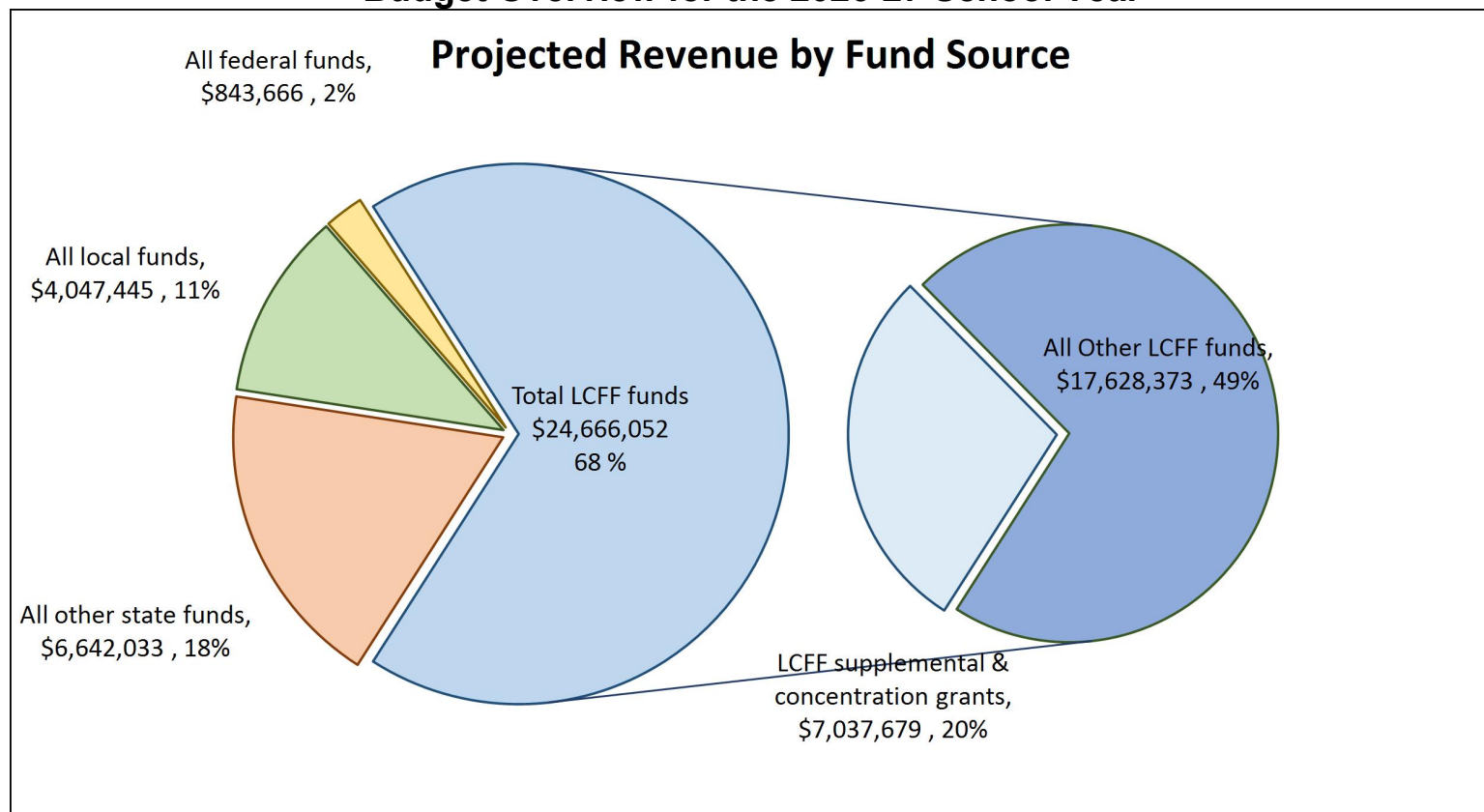

Budget Overview for the 2026-27 School Year

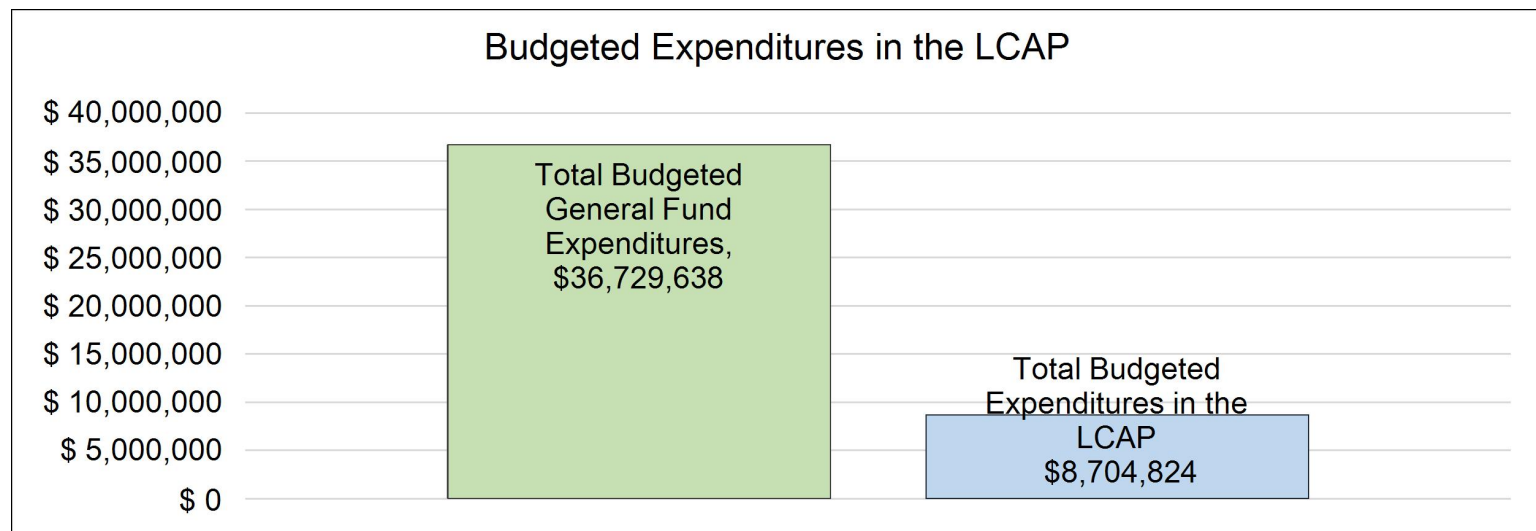


This chart shows the total general purpose revenue Nuvview Union School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Nuvview Union School District is \$36,199,196, of which \$24,666,052 is Local Control Funding Formula (LCFF), \$6,642,033 is other state funds, \$4,047,445 is local funds, and \$843,666 is federal funds. Of the \$24,666,052 in LCFF Funds, \$7,037,679 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

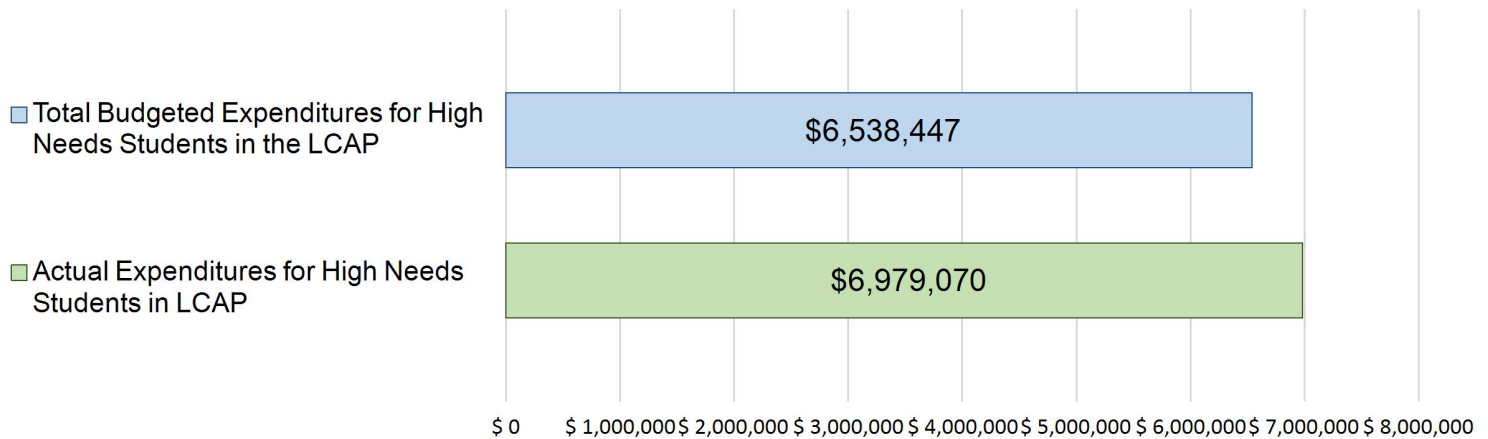
Increased or Improved Services for High Needs Students in the LCAP for the 2026-27 School Year

Plan Summary [2026-27]

General Information

The Nuvew Union School District (NUSD) is a small district serving students from transitional kindergarten to 8th grade in the Lakeview, Perris, and Nuevo communities. It is comprised of two elementary schools for TK-6th grade and one middle school for 7th and 8th grades, with a total student population of 1557 students. The current Average Daily Attendance stands at 94% , 88.4% of NUSD students are classified as Socio-Economically Disadvantaged, and 29.2 % are English language learners (EL). The student body is predominantly Hispanic (85.2%), followed by White (9.2%) students, with smaller percentages of African American (1%), multiracial (3%), Asian (0.6%), American Indian (0.1%), Filipino (0.3%), and Pacific Islander (0.4%) students. Additionally, 15.4% are students with disabilities (SWD), 11.4% are experiencing homelessness, and 1% are foster youth.

NUSD is committed to fostering high expectations, beginning with quality classroom instruction. The curriculum includes Eureka Math for all grades, Engage New York ELA for grades 4 through 8, and McGraw Hill Wonders for TK-3. Amplify Science is used TK-8 to address Next Generation Science Standards and TCI for Social Studies. Two Teachers on Special Assignment (TOSA) per elementary school and at the Middle School provide Tier 2 Intervention in math and English language arts. Intervention programs such as I-Ready and IXL are utilized, with Read 180 at the middle school level. Additionally, elementary schools have full-time PE teachers to support small group interventions. Positive Behavior Intervention Supports (PBIS) are implemented district-wide.

Safety is a top priority, emphasized through feedback from educational partners and addressed by board subcommittees, like the Safety Subcommittee and Facilities Subcommittee, ensuring community engagement and prioritizing safety in decision-making.

Our local data (IReady) shows that 70% of our students are performing at least one grade level below in reading, and 77% are performing at least one grade below in math. According to our local data, 84% of our English Learners are one or more grade levels below in reading, and 88% of our English Learners are one or more grade levels below in math.

The LEA will address these concerns through focused professional development in math and ELD. Increased staffing for students with disabilities to lower ratios and a focus on chronic absenteeism at school sites with incentives for improved attendance. In addition, continued focus on ELs through teacher planning time and intervention for the unduplicated students.

Areas that have shown growth on the 2025 California School Dashboard include Math, Chronic Absenteeism and Suspension.

NUSD has unexpended LREBG Funds available to be expended in the 2026-2027 school year.

Based on the NUSD needs assessment, the academic performance of Socioeconomically disadvantaged and English Learners is an area of need.. This action will address the need under the allowable use of tutoring or other one-on-one or small group learning supports provided by certificated or classified staff, and providing professional development and coaching on the ELA and Math Framework. This action has been chosen based on student need and research based practices to support the action:

Action 1.6: Research has shown that smaller class sizes can lead to significant improvements in student learning, especially in the early grades. A smaller class size allows the instructor to deliver a more tailored education, which increases the likelihood of meeting each student's requirements and concerns. This may create a learning environment where students feel recognized and understood, which will boost their engagement and drive (Ajami and Akinyele, 2014)

Reflections: Technical Assistance

The 2023 California School Dashboard shows that our Students with Disabilities are eligible for Differentiated Assistance in ELA, Math, and Suspension. In addition, our English Learners are eligible in math and suspension. We are now in Year Two of support provided to us by RCOE.

District leaders and site principals have participated in Differentiated Assistance meetings and the Compliance and Improvement Monitoring Process to establish the root causes of these students' challenges. Through this process, we have established plans to address the concerns.

Per the 2025 Dashboard, our district is eligible for technical assistance for Long Term English Learners in their progress in English Language Development, Suspension and chronic absenteeism. District Leaders have met with County Leaders to analyze the data and determine best supports moving forward. Integrated ELD training for all teachers will take place at Mountain Shadows Middle School, where a majority of students identified as long term English Learners attend.

District leaders and site principals have participated in the Compliance and Improvement Monitoring Process to establish the root causes of these students' challenges. Through this process, we have established plans to address the concerns.

In the CIM plan, there was one activity that was created to address the root causes:

1. Using short-term independent study at a greater rate than just missed school days.

The LCAP survey, Dashboard Data, and minutes from staff LCAP meetings were reviewed. Goals and Actions were reviewed, and input was provided. Discussion took place to gather feedback on what goals and actions should be maintained in the 2026-2027 LCAP.

Educational partner feedback influenced the development of the adopted LCAP, ensuring that we were reflective in addressing the needs of our students and those identified by our educational partners. This resulted in updating one of our actions to better reflect the needs demonstrated. Based on the input that the STEM lab at the elementary sites was not being utilized, Action 1.7 was changed to the STEM aide being changed to a STEAM aide and assisting with Art as well.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the second year of implementation for Goal 1, the district implemented all planned actions. The core focus areas—Action 1.1 student achievement in ELA and Math, and 1.2 Supplemental Instructional Programs and Materials —were implemented as intended, with few substantive deviations from the original plan. In Action 1.7, there was a shift in focus as our Elementary Sites determined that time spent in the STEM lab was preventing teachers from addressing Science Standards within the classroom. There was a shift to reduce time in the STEM lab and staffing used for that was shifted to enhance the Art Program that has been implemented. Successes in this goal include a perception by families, staff and students that extracurricular activities are provided to our students. At baseline, 40% felt the district was not providing these opportunities and in the 2025 LCAP survey, that has reduced to 20%. Challenges include many student groups continue to perform below standard, indicating the need for continued targeted interventions and accelerated learning supports. Additionally, the percentage of highly qualified teachers declined from 97.4% to 92%, reflecting ongoing staffing and recruitment challenges that affected full implementation of the district's goal of maintaining 100% highly qualified staff. Another challenge was the inability to measure progress toward local assessment goals using end-of-year i-Ready data, as the Spring Diagnostic had not yet been administered during the reporting period. As a result, progress toward reducing the percentage of students performing below grade level could not yet be fully evaluated.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Any differences in expenditures listed below exceed a 10% threshold from the original budget.

Supplemental Instructional Programs and Materials (1.2) were budgeted at \$208,966, but actual expenditures increased to \$335,256.00 due to higher costs of supplemental materials used to meet academic needs in ELA and math.

Enrichment Opportunities (1.7) were budgeted at \$258,771.00, but actual expenditures were \$220,270.00. This decrease was due to a reduction in supplies needed to provide enrichment opportunities.

Site Allocations - Academic (1.10) were budgeted at \$80,486.00, but actual expenditures were \$63,853.00. This decrease was due to a reduction in supplies needed by the sites to address the academic needs of the students.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The specific actions implemented to support student achievement and school improvement have shown measurable effectiveness in making progress toward the district's goals. Multiple metrics demonstrate improvement from baseline data, particularly in academic achievement, student engagement, enrichment opportunities, and expanded access to support programs.

Districtwide CAASPP performance improved in both English Language Arts and Mathematics. ELA performance improved by 19.5 points from baseline, while Math improved by 13.8 points. Students with Disabilities also demonstrated notable growth, with ELA improving by 20.3 points and Math improving by 24.4 points from baseline. Homeless student performance also showed progress, with improvements of 24.7 points in ELA and 17.3 points in Math. English Learners demonstrated a 10.4-point improvement in Math performance.

Actions focused on improving school culture and engagement have also been effective. Student engagement survey results increased from 62.8% to 87% of respondents reporting that students are engaged in classes and activities. Additionally, the percentage of respondents reporting that the district does not provide extracurricular activities decreased significantly from 40.9% to 16.9%, demonstrating that expanded enrichment and extracurricular opportunities are having a positive impact on student experiences.

The Beyond the Bell expanded learning program has also proven effective, with enrollment increasing from 253 students to 335 students, an increase of 82 students. This growth reflects increased family participation and access to academic and enrichment supports outside the regular school day.

Additional actions related to maintaining standards-aligned instructional materials, access to technology, and broad course offerings have remained effective and stable. The district maintained 100% Williams compliance, continued providing standards-aligned instructional materials and device access for students, and sustained implementation of required course offerings.

Learning Recovery Emergency Block Grant has been added to Actions 1.6. We will continue with the actions established at the start of the plan.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The specific actions implemented to support English Learners have shown moderate to strong effectiveness across several key areas.

2.1 Teachers were provided with GLAD training and site ELD training. The district anticipated training twenty teachers this school year. Based on availability of trainers, we were reduced to one training and only able to train ten teachers.

2.2 English Learners were provided with support to become English Proficient. Daily designated and integrated ELD. ELPAC was administered, monitoring of progress took place and ELAC and DELAC meetings were held.

2.4 Site allocations there was a reduction in spending due to the reduction in substitutes used to provide the GLAD training. The district anticipated two trainings and only one training was able to be provided.

Overall, the actions supported growth for a smaller percentage of students than the previous school year based on Dashboard data.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Any differences in expenditures listed below have a 10% threshold from the original budget.

For Action 2.1 (Training to Support English Learners), expenditures decreased from the budgeted \$26,490 to \$2,410 due to a reduction in the number of planned trainings and fewer staff participating in GLAD professional development.

For Action 2.2 (Support for English Learners to Become English Proficient), actual expenditures totaled \$184,435, which is below the planned budget of \$293,432. This decrease is attributed to staffing vacancies and lower-than-anticipated substitute costs associated with ELPAC administration.

For Action 2.4 (Site Allocations – English Learner Development), expenditures were also below budget, with \$19,675 spent compared to the allocated \$61,680. These site-based funds were reallocated to other goals in alignment with site SPSAs, primarily to support climate and safety.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

English Learner math performance has improved incrementally, decreasing from 98.8 points below standard in 2023 to 88.4 points below standard in 2025, reflecting a 10.4 -point gain. While this demonstrates that instructional supports and interventions are having a positive impact, performance remains well below standard, indicating that the actions have been only partially effective in accelerating achievement. Progress on the ELPAC also reflects partial effectiveness. The percentage of students making progress toward English Language Proficiency increased from 42.5% in 2023 to 49.5% in 2024, but then declined to 38% in 2025. Despite an overall net increase of 7 percentage points from baseline, the fluctuation indicates that gains have not been consistently maintained.

Site-level data further supports a trend of gradual improvement. English Learners showed gains in math performance at Mountain Shadows Middle School, along with a notable 11.3% decrease in suspension rates. At Nuview Elementary, English Learner progress increased significantly by 38.2%. Valley View Elementary also demonstrated improvement in both ELA (16.1 points) and Math (27.4 points) for English Learners. These site-based gains indicate that targeted actions are producing positive outcomes at the local level.

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The implementation of planned actions was largely successful, particularly in attendance and safety. There was an increase in this area due to an increased contribution to transportation. Counseling and mental health services were expanded to better serve unduplicated students.

However, a challenge was encountered in fully implementing behavioral support training due to a shortage of substitute teachers in the fall of 2025.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Any differences in expenditures listed below have a 10% threshold from the original budget.

Action 3.1 (Professional Development for Behavioral Support): actual expenditures were significantly lower than budgeted, dropping from \$56,381 to \$ 32,719. The district was only able to provide one training session due to a substitute teacher shortage in the fall, which reduced the number of sessions.

Action 3.2 (Counseling and Mental Health Services) saw a decrease in spending from \$960,585 to \$864,302 Use of grant funds for this action reduced planned expenditures, which did not affect implementation of the goal.

Action 3.3 (Improving Student Attendance) also saw an increase in actual expenditures—from \$595,421 to \$751,374—This was based on an increased contribution to transportation.

Action 3.5 (Parent and School Connectness) saw a decrease from \$107,435 to \$95,248. This was due to reduced travel and conferencing expenditures.

Action 3.7 (School and Classroom Environment): The budgeted amount was \$214,106, and the amount spent was \$258,236. This was due to site facility improvements that enhanced the learning environment for students.

Action 3.8 (Site Allocation-School Climate): The budgeted amount was \$94,442, and the amount spent was \$76,353. This was due to a reduction in spending on field trips.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

When comparing the baseline data directly to the Year 2 outcomes, the specific actions implemented to date have yielded highly successful results in educational partner engagement, school climate, and facility operations. Efforts focused on parent involvement and participation proved effective, as reflected by an increase in parents reporting that the district provides useful workshops, climbing from a baseline of 54.1% up to 60.72% in the Year 2 outcomes. Similarly, parent participation in advisory committees saw a rise, growing from a baseline of 58.9% to 72.3% in Year 2. School safety initiatives also successfully fostered a more positive environment across the district, with the percentage of respondents feeling safe on campus growing steadily from a baseline of 60.1% to 72.2% in Year 2. Furthermore, facility maintenance actions consistently met high operational standards, successfully maintaining a stable ranking of "Good" on the annual Facility Inspection Tool (FIT) from the baseline through the Year 2 outcomes.

In contrast, actions targeting staff development and student behavior demonstrate more moderate or mixed effectiveness when evaluating the shift from baseline data to Year 2 outcomes. Professional development efforts showed positive progress, resulting in a minor increase in stakeholders agreeing that teachers and staff care about students, which rose from a baseline of 60.9% to 77.3.6% in Year 2. Meanwhile, behavior-related interventions achieved positive stabilization across most demographics; the district-wide student suspension rate fell from 6.4% at baseline to 4.4% in the Year 2 outcomes, with more pronounced drops among high-need subgroups. Expulsion rates decreased from 3 last year to 0 this year. Site data showed improved behavior and attendance at all three sites with the exception of an increase by .5% in suspension for students identified as hispanic at Nuvview Elementary.

Additional Concentration Grant Funding

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Additional concentration grant add-on funding supplements actions 1.6, 1.8, 3.6, and 3.7. In action 1.6, we continued using the concentration grant add-on to retain three additional teacher positions hired to lower class size ratios beyond the bargaining unit contract class sizes. In action 1.8, we continued the two assistant principal positions and used the concentration grant add-on funding for approximately 50% of the salaries. The intent of these positions is to monitor our unduplicated students with individual learning plans and provide assistance in programs and interventions. These positions plan and administer our after-school and extended learning programs for unduplicated students. In action 3.7, we continued the additional custodial positions to provide direct service to students by ensuring our campuses remain clean and safe. In action 3.6, we added the position of campus security at each school for the direct safety and security of our students.

The percentage is calculated based on the amounts of the Estimated Actual LCFF Base Grant (9) and the Estimated Actual LCFF Supplemental and/or Concentration Grants (6), pursuant to 5 CCR Section 15496(a)(8), plus the LCFF Carryover – Percentage from the prior year. This is the percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all students in the current LCAP year.

Calculations in the Action Tables

To reduce the duplication of effort of LEAs, the Action Tables include functionality such as pre-population of fields and cells based on the information provided in the Data Entry Table, the Annual Update Summary Table, and the Contributing Actions Table. For transparency, the functionality and calculations used are provided below.

Contributing Actions Table

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
 - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **Difference Between Planned and Estimated Actual Expenditures for Contributing Actions (Subtract 7 from 4)**
 - This amount is the Total Estimated Actual Expenditures for Contributing Actions (7) subtracted from the Total Planned Contributing Expenditures (4).
- **5. Total Planned Percentage of Improved Services (%)**
 - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
