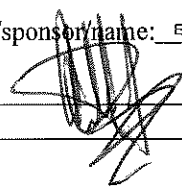

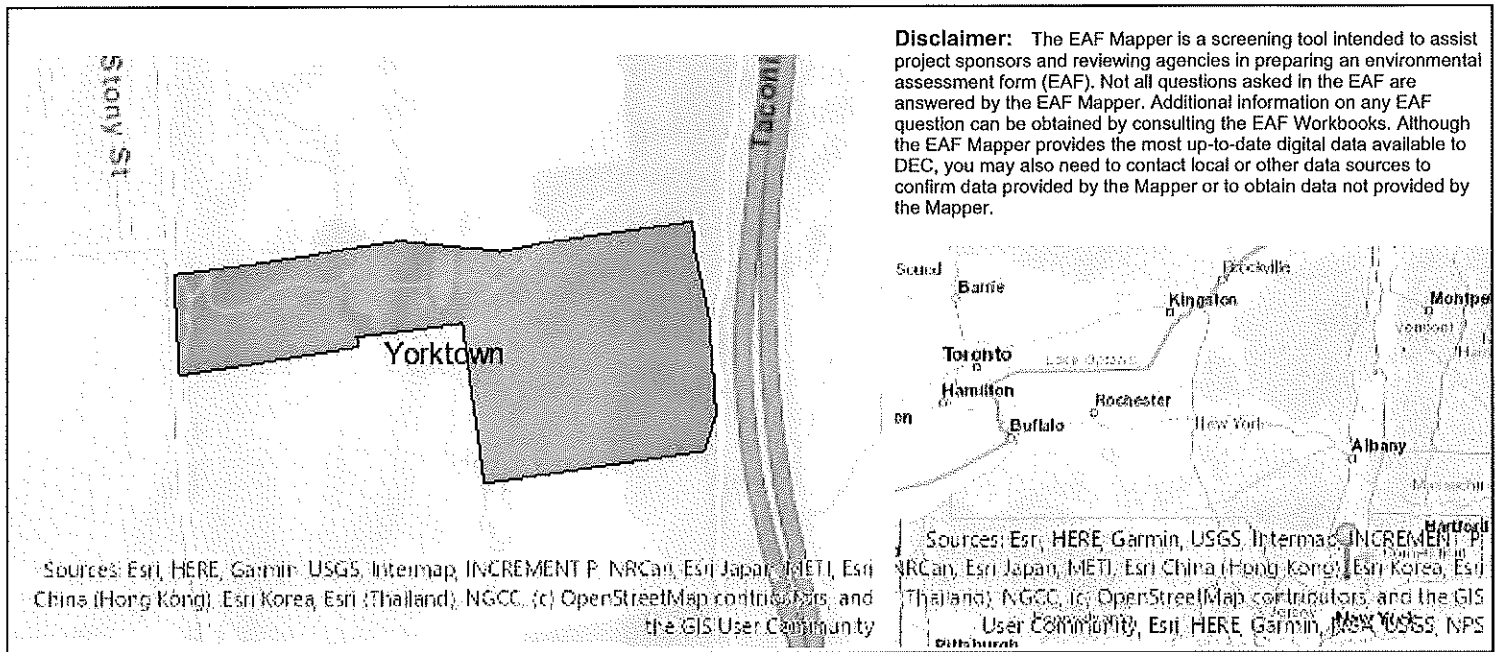

Name of Action or Project: Tom Diana Park at Granite Knolls Sports and Recreation Complex			
Project Location (describe, and attach a location map): 2975 Stony Street Mohegan Lake, NY			
Brief Description of Proposed Action: It is proposed to pave the existing gravel parking lot at Tom Diana Park at Granite Knolls Sports and Recreation Complex as per the NYC DEP approved plan. The plan requires a combination of porous asphalt and standard asphalt pavement with a stone reservoir below. This construction will require removal of approximately 5,200 cy of existing soil and gravel. It is proposed to transport the removed soil to one or two locations where it will be spread and stabilized for potential future parking areas. Approximately 6,400 sf of this area is within a wetland buffer requiring a wetland permit. Additionally, it is proposed to construct a beach volleyball court in place of what was originally the putting green and picnic area. This will require removing approx. 50 cy of existing soil to a depth of approximately 12" - 18" and replacing that with beach sand. See attached site plan.
